Hamburg, Decemb. 7. We hear from *Stockholm*, That the the King of *Sueden* intends to keep all this Winter 14 or 15000 Men in *Schonen*; and that a considerable Body of Men will be likewise Quartered about *Gottenburg*. They write from *Stade*, That the 6000 *Suedes* which are to pass into the Service of the States-General of the United Provinces would begin their March in few days. We are told from *Copenhagen*, That the Count de *Chiverny*, Ambassador of *France* at that Court, had had his Audiences of Leave; and that his Successor, the *Sieur de Martangis*, arrived there the 24th of the last Month. Our Ships from *Moscow* are arrived in the *Elbe*.

Cologne, Decemb. 10. The Letters from *Baden* in *Switzerland* of the 28th past give an account, That the Cantons had at the late Dyet resolved to take the four Forest Towns and the City of *Constance* under their Protection, into which last place they had put a good Garison, and that to support this Resolution they would form an Army of 30000 men; and if that was not sufficient, of 60000. That they had actually commanded all their Subjects now in the Service of *France* not to serve against the Empire, upon pain of Death and Confiscation of Goods. In all appearance the Confederates Troops will in a short time oblige the French to quit the Palatinate and the Electorates of *Mayence* and *Cologne*, but in the mean time these Countreys are miserably destroyed.

Whitehall, Decemb. 16. His Majesty returned hither this Evening in very good Health. His Highness the Prince of *Orange* came to *Windsor* on Friday last; from whence he has sent the *Sieur de Zulestein* to His Majesty, who has likewise sent the Earl of *Feversham* to his Highness, to invite him to *St. James's*.
