Cuckfield Union.—Parishes of Clayton and Keymer.

To the Guardians of the Poor of the Cuckfield Union, in the county of Sussex, being the Rural Sanitary Authority for that Union :

To the Churchwardens and Overseers of the several parishes of Clayton and Keymer, in the said Union :

And to all others whom it may concern.

WHEREAS by Section 23 of the Public Health Act, 1872, it is enacted that the Local Government Board may, on the application of the Authority of any Rural Sanitary District, by Order, to be published in the London Gazette, or in such other manner as they may direct, invest such Authority with all or any of the powers, rights, duties, capacities, liabilities, and obligations of an Urban Sanitary Authority ; and that such investment may be made either unconditionally or subject to any conditions to be specified by the Board as to the time, portion of district, or manner during, at, and in which such powers, rights, duties, capacities, liabilities, and obligations are to be exercised and attach ;

And whereas the Guardians of the Poor of the Cuckfield Union, in the county of Sussex, being the Rural Sanitary Authority for that Union, have applied to the Local Government Board to issue an Order investing them, as such Sanitary Authority, with certain of the powers, rights, duties, capacities, liabilities, and obligations of an Urban Sanitary Authority, as regards the parish of Clayton and Keymer, in the said Union :

Now, therefore, We, the Local Government Board, having duly considered the said application, do hereby, in pursuance of the powers given by the Statutes in that behalf, invest the Guardians of the Poor of the Cuckfield Union, as such Sanitary Authority as aforesaid, from and after the 9th day of November, 1874, with all the powers, rights, duties, capacities, liabilities, and obligations of an Urban Sanitary Authority, as regards the parishes of Clayton and Keymer, with reference to making bylaws, and otherwise, in respect to the following matters, viz. :—

In respect to the various matters mentioned in Section 64 of the Public Health Act, 1848.

In respect to the various matters mentioned in Section 32 of the Local Government Act, 1858, so far as the powers under that section are not already conferred upon the said Sani-

tary Authority in pursuance of Section 8 of the Public Health Act, 1872, and Section 5 of the Sanitary Act, 1868.

In respect to the various matters mentioned in Section 34 of the Local Government Act, 1858.

And in respect to Slaughter-houses, under Section 45 of the same Act.

And We hereby direct the said Guardians to cause this our Order to be published once in some newspaper circulated within the Rural Sanitary District of the said Union, before the expiration of one calendar month from the date hereof.

Oxfordshire and Warwickshire Audit District.

WHEREAS the Poor Law Commissioners, acting under the authority of "The Poor Law Amendment Act, 1834," and "The Poor Law Amendment Act, 1844," by an Order under their hands and seal, dated the 24th day of April, 1845, combined the following Unions, namely, the Alcester, Banbury, Chipping Norton, Droitwich, Evesham, Foleshill, Northleach, Pershore, Rugby, Shipston-upon-Stour, Solihull, Southam, Stow-on-the-Wold, Stratford-upon-Avon, Warwick, Witney, Woodstock, and Worcester Unions, together with the parishes of Saint Michael and the Holy Trinity, in the city of Coventry and county of the same city, into a district for the audit of accounts, to be termed "The Oxfordshire and Warwickshire Audit District," and thereby ordered and directed that one person should be appointed as the Auditor of the said district ;

And whereas by an Order dated the 22nd day of July, 1847, the said Commissioners added the parish of Edgcott, in the county of Northampton, to the said Banbury Union ;

And whereas by an Order dated the 3rd day of April, 1851, the Poor Law Board added the parish of Brinklow, in the said county of Warwick, to the said Rugby Union ;

And whereas by an Order dated the 8th day of April, 1851, the Poor Law Board added the parish of Bedworth, in the said county of Warwick, to the said Foleshill Union ;

And whereas the Poor Law Board by an Order dated the 9th day of May, 1851, added the parish
