### Board of Trade (Harbour Departmeut), Whitehall Gardens, November 20, 1874.

THE Board of Trade have received through the Secretary of State for the Colonies a copy of a Despatch from the Governor of Barbados, enclosing copy of a proclamation declaring the port of Kingston (Jamaica) to be infected with smallpox, and that every vessel arriving therefrom, which has had free communication with the shore, and all persons landing therefrom, shall be placed in quarantine for fourteen days from the date of such vessel leaving the said port ; and that all vessels of the Royal Mail Steam Packet Company arriving from the said port within the aforesaid period of fourteen days, shall be likewise placed in quarantine, unless they produce a certificate that they have not had free communication with the shore, but have only received on board passengers or cargo for England, or certain cargo, as hereinafter specified, for Barbados; in which case, if there be no sickness on board upon arrival at Barbados, no restriction will be placed upon them, beyond that of not being allowed to disembark any passengers who have had communication with Jamaica, or to land cargo from that island, except in quarantine and under such restrictions as the Governor shall from time to time establish; provided, however, that for the present coffee in barrels or other wooden packages may be landed in free pratique. The epidemic is, however, supposed to be abating.
