By virtue of an Act passed in the twentyfourth year of the reign of His Majesty King George III, intituled "An Act to repeal so "much of two Acts made in the tenth and "fifteenth years of the reign of His present "Majesty, as authorizes the Speaker of the "House of Commons to issue his Warrant to "the Clerk of the Crown for making out writs " for the election of Members to serve in Par-"liament, in the manner therein mentioned, and "for substituting other provisions for the like purposes;" and of an Act passed in the twenty-sixth year of the reign of Her present Majesty, intituled "An Act to further limit and define "the time for proceeding to Election during the " Recess:
