### CRIMPLESHAM FAIR.

WHEREAS a representation has been duly made to me, as Secretary of State for the Home Department, by the Justices acting in the Clackclose Petty Sessional Division of the county of Norfolk, that a Fair has been annually held on the second Monday after Whitsuntide in the parish of Crimplasham, in the said division of the said county, and that it would be for the convenience and advantage of the public that the said Fair should be abolished:

And whereas notice of the said representation, and of the time when I should take the same into consideration, has been duly published in pursuance of "The Fairs Act, 1871:"

And whereas, on such representation and consideration, it appears to me that it would be for the convenience and advantage of the public that the said Fair should be abolished:

And whereas Sir William Bagge, Bart., as lord or owner of the said Fair, and the tolls thereof, has consented in writing that the said Fair should be abolished:

Now, therefore, I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1871," do hereby order that the Fair which has been annually held on the second Monday after Whitsuntide in the parish of Crimplasham, in the Clackclose Petty Sessional Division of the county of Norfolk, shall be abolished as from the date of this order.

## THE FAIRS ACT, 1873.

### WINCHESTER FAIR.

WHEREAS a representation has been duly made to me, as Secretary of State for the Home Department, by the Council of the city of Winchester, as owners, that a Fair has been annually held on the first Monday in Lent in the said city, and that it would be for the convenience and advantage of the public that the day for the holding of such Fair should be altered, and that such Fair should cease to be held on the first Monday in Lent, and should be held instead on the last Saturday in February in each year.
