THE Queen has been pleased to approve of Dr. juris Ernst Bieber as Consul at Singapore for the German Empire.

The Queen has also been pleased to approve of Mr. Nataniel Webb Ware as Consul at Cork for the Argentine Republic.

The Queen has been pleased to grant unto John Schilizzi, of Cleveland-gardens, in the parish of Paddington, in the county of Middlesex, Gentleman, and to his brothers, Lucas Schilizzi and Matthew Schilizzi, both minors, Her Royal licence and authority that they may, in compliance with a request contained in the last will and testament of Giovanni Vafiadacchi, late of the city of Leghorn, in the Kingdom of Italy, Merchant, deceased, take and use the surname of Vafiadacchi in addition to and before that of Schilizzi, and that he and they may bear the arms of Vafiadacchi quarterly with those of Schilizzi, and that such surname and arms may in like manner be taken, borne, and used by their issue respectively; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.
