

chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent of the vicarage of Saint Saviour, Birmingham, in the county of Warwick, and in the diocese of Worcester, and to his successors, Incumbents of the same vicarage, one yearly sum or stipend of two hundred pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the first day of May, in the year one thousand eight hundred and seventy-five, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: Provided always,

that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

In witness whereof, we have hereunto set our common seal, this third day of June, in the year one thousand eight hundred and seventy-five.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the vicarage of Little Hereford with Ashford Carbonell, in the counties of Hereford and Salop, and in the diocese of Hereford, and to his successors, Incumbents of the same vicarage, all and singular those annual tithe commutation rent-charges, which are particularly described in the schedule hereunto annexed, and are now vested in us: To have and to hold the said annual tithe commutation rent-charges, to the use of the said Incumbent and his successors for ever: Provided always, that the said annual tithe commutation rent-charges expressed to be hereby granted and conveyed, shall be, and be taken to be, in lieu of, and in full substitution for, both the annual sum or stipend of ten pounds, heretofore payable by us, the said Commissioners, or by our lessee, to the Incumbent for the time being of the said vicarage, in respect of the said and other tithe commutation rent-charges arising within the parish of Little Hereford aforesaid, and also for the further annual sum or stipend of ninety-five pounds heretofore payable by us, the said Commissioners, to the Incumbent for the time being of the said vicarage, under the authority of an Order of Her Majesty in Council, bearing date the twenty-seventh day of July, in the year one thousand eight hundred and sixty-three, and published in the London Gazette of the twenty-eighth day of the same month and year, to which substitutions the Reverend Llewellyn Jones, the present Incumbent of the said vicarage, is consenting, and in token thereof has signed this Instrument; And provided further, that the Incumbent for the time being of the same vicarage shall be entitled to receive from us, or on our account, the net amount of the profits and proceeds of the said annual tithe commutation rent-charges, for and in respect of the period intervening between the first day of May, in the year one thousand eight hundred and seventy-four, and the date of the publication of these presents in the London Gazette.
