WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction, consisting of a sum of three hundred pounds sterling, which has been paid to us in favour of the vicarage of Saint Katharine, Felton Common Hill, in the county of Somerset, and in the diocese of Bath and Wells, and of certain other benefactions, consisting of (1) two pieces or parcels of land, comprising one acre three roods and twenty-five perches, with a cottage thereon, and three acres two roods and thirty-one perches respectively, (2) impropriate tithe commutation rent-charges, amounting to nine pounds per annum, and (3) certain other tithe commutation rent-charges, amounting to twenty pounds, and heretofore forming part of the revenues of the rectory of

Winford, in the said county of Somerset, all of which benefactions have been permanently secured to the said vicarage of Saint Katharine, Felton Common Hill, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said vicarage of Saint Katharine, Felton Common Hill, to meet the aforesaid benefactions, one capital sum of one thousand two hundred and thirteen pounds sterling, to be applicable towards defraying the cost of providing a parsonage or house of residence for the said vicarage, according to plans and a specification to be approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands at interest after the rate of three pounds per centum per annum, and such interest to be paid to the incumbent for the time being of the said vicarage of Saint Katharine, Felton Common Hill.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant and convey to the Incumbent of the consolidated chapelry and benefice of Saint Peter, Mill End, in the county of Hertford, and in the diocese of Rochester, and to his successors, Incumbents of the same consolidated chapelry and benefice, all and singular those annual tithe commutation rent-charges which are particularly described in the schedule hereunto annexed, and are now vested in us: to have and to hold the said annual tithe commutation rent-charges to the use of the said Incumbent and his successors for ever: Provided always, that the Incumbent for the time being of the same consolidated chapelry and benefice shall be entitled to receive from us, or on our account, the net amount of the profits and proceeds of the said annual tithe commutation rent-charges, for and in respect of the period intervening between the twenty-ninth day of June, in the year one thousand eight hundred and seventy-five, and the date of the publication of these presents in the London Gazette.
