ORDER issued by the Local Government Board fixing Boundaries of Wards under Local Act :-

> Ulverstone Union. Borough of Barrow-in-Furness.

To the Mayor, Aldermen, and Burgesses of the borough of Barrow-in-Furness, in the county of Lancaster:-

And to all others whom it may concern.

WHEREAS by the "Barrow-in-Furness Corporation Act, 1875," it is enacted that on and from the 1st day of November, 1875, the Borough of Barrow-in-Furness as thereby extended shall be divided into Eight Wards, the names or distinguishing numbers and boundaries of which shall be fixed and determined by the Local Government Board upon the report of a Commissioner to be for that purpose appointed by them within two weeks after the passing of that Act, and that the Commissioner shall make his report to the Local Government Board before the 1st day of September, 1875, and that such report shall be subject to revision by the Local Government Board, who shall make such Order therein as they think fit;

And whereas it is thereby further enacted that the said Order shall be published before the end of September, 1875, in the London Gazette, and in a newspaper circulating in the said Borough of Barrow-in-Furness, and that after such publication the names or numbers and boundaries of the wards as set forth in such Order shall be the names or numbers and boundaries thereof for all purposes as if they had been specially set forth in the said Act;

And whereas the said Act received the Royal Assent on the 11th day of August, 1875; and on the 14th day of August, 1875, the Local Government Board appointed Gerald Augustus Robert FitzGerald, of Lincoln's-inn, in the county of

Commissioner for the purpose above-mentioned; and the said Commissioner made his report to the Local Government Board before the 1st day of September, 1875, namely, on the 28th day of August, 1875.

Now, therefore, we, the Local Government Board having duly considered the report so made to us, do hereby, under the authority of the above-mentioned Act, and of the several other statutes in that behalf, order that the eight wards into which the Borough of Barrow-in-Furness, as extended by the said Act, is to be divided on and from the 1st day of November, 1875, shall be named respectively the Walney Ward, the Hindpool Ward, the Ramsden Ward, the Central Ward, the Salthouse Ward, the Hawcoat Ward, the Newbarns Ward, and the Yarlside Ward, and that the boundaries of the said wards respectively shall be those set forth in the schedule to this Order.

The SCHEDULE above referred to.

WALNEY WARD .- The boundary of the Walney Ward shall be as follows:-

An imaginary line commencing at the south-eastern extremity of Walncy Island, known as South-east Point, and extending thence in a westward and northerly direction along the borough boundary to the north-east point of North End Haws; thence in a south-easterly direction to a point in the centre of Walney Channel due west of the point where the borough boundary touches the shore of the mainland, near Sowerby Wood; thence along the centre of Walney Channel to a point in the Channel due west of the entrance basin situate between the northern extremity of Barrow Island and the mainland, to the Devonshire Dock; thence in a direction due east to the north side of the entrance basin to the Devonshire Dock; thence along the north-east wall of the basin to the Devonshire Dock; thence along the north-west, north-east, and south-east walls of the Devonshire Dock, to the entrance from the Devonshire Dock to the Buccleuch Dock; thence along the north side of the entrance and the north-west, north-east, and south-east walls of the Buccleuch Dock to the entrance basin between the Buccleuch and Ramsden Docks; thence along the north side of that basin to the centre of the branch line of the Furness Railway crossing such basin; thence in a northeasterly direction along the south-eastern side of such branch line and of the main line of the said Middlesex, Esquire, Barrister-at-Law, to be the railway to a point where the Furness Railway Company's out-fall sewer passes under the said railway; thence in a southerly direction along an imaginary straight line to North-east point in Walney Island; and thence in a south-easterly direction along the shore to the point of commencement.

HINDPOOL WARD.—The boundary of the Hindpool Ward shall be as follows:—

An imaginary line commencing at the most northerly point of the Devonshire Dock, and extending thence in a south-westerly, westerly, north-westerly, and northerly direction along the boundary of Walney Ward to a point in the centre of Walney Channel due west of the centre of the railway bridge of the loop line of the Furness Railway over Ormsgill Nook; thence due east to the centre of the said railway bridge; thence in a south-easterly direction along the north-eastern side of such loop line to a point where an imaginary straight line drawn along the centre of Drake-street across Holker-street and the ground lying between Holker-street and such loop line would meet such loop line; thence in a southwesterly direction along such imaginary straight line across such intervening ground and Holkerstreet, and along the centre of Drake-street and Nelson-street to a point where such last-mentioned street forms a junction with Duke-street: thence in a straight line across Duke-street and the ground intervening between Duke-street and Hindpoolroad to a point where North-road forms a junction with Hindpool-road; and thence along the centre of North-road to a point in the centre of Northroad opposite the western corner of the Harbour Master's Office; and thence in a straight line to the point of commencement.

RAMSDEN WARD.—The boundary of the Ramsden Ward shall be as follows:—

An imaginary line commencing at the most northerly point of the Devonshire Dock, and extending thence along the south-eastern boundary of Hindpool Ward to the loop line of the Furness Railway; thence along the north-eastern side of the loop line in a south-easterly direction to a point where an imaginary line drawn along the centre of Crellin-street would join such loop line; thence in a south-westerly direction along such imaginary line to a point where Forshaw-street joins Crellin-street; thence along the centre of Forshaw-street to the point of junction of that street and Duke-street; thence for a short distance in a south-easterly direction along the centre of Duke-street to the point of junction of Duke-street and Cornwallis-street; thence in a south-westerly direction along the centre of Cornwallis-street, across Hindpool-road, and the line of the Furness Railway, to a point in the Dock Wall opposite the south-east corner of the Devonshire Dock Warehouses, to be marked by a boundary stone; and thence in a westerly direction along the north side of the Devonshire Dock Wall to the point of commencement.

CENTRAL WARD.—The boundary of the Central Ward shall be as follows:—

An imaginary line commencing at a point in the Dock Wall opposite the south-east corner of the Devonshire Dock Warehouses, to be marked by a boundary stone, and extending thence along the south-eastern boundary of Ramsden Ward to the loop line of the Furness Railway; thence along the north-eastern side of the loop line in a south-easterly direction to the point where an imaginary straight line drawn along the centre of Ramsden-street and across the ground intervening between such street and the loop line

would meet such loop line; thence along such imaginary straight line and the centre of Ramsdenstreet to its junction with the Strand; thence along an imaginary straight line drawn across the Strand, in a south-westerly direction, to a point in the wall of the Buccleuch Dock, to be marked by a boundary stone; and thence in a direction generally north-westerly along the boundary of Walney Ward to the point of commencement.

SALTHOUSE WARD.—The boundary of the Salthouse Ward shall be as follows:—

An imaginary line commencing at a point in the Buccleuch Dock Wall, to be marked by a boundary stone, and extending thence along the south-eastern boundary of Central Ward to the loop line of the Furness Railway; thence in a south-easterly direction along the north-eastern side of the loop line to its junction with the main line of the Furness Railway from Barrow to Dalton; thence first in a south-westerly and then in a north-westerly direction along the boundary of Walney Ward to the point of commencement.

HAWCOAT WARD. — The boundary of the Hawcoat Ward shall be as follows:—

An imaginary line commencing at a point in the centre of Abbey-road where that road crosses the loop line of the Furness Railway; thence extending in a north-westerly direction along a portion of the north-eastern boundary of Ramsden Ward and along the north-eastern boundary of Hindpool Ward to a point in the centre of Walney Channel due west of the centre of the railway bridge of the loop line of the Furness Railway over Ormsgill Nook; thence in a northerly direction along the boundary of Walney Ward in Walney Channel to the point in the centre of the Channel due west of the point where the borough boundary touches the shore of the mainland near Sowerby Wood; thence in a line due east to such last-mentioned point; thence first in a north-easterly and then in a southerly direction along the boundary of the borough to a point where such boundary crosses the main line of the Furness Railway from Barrow to Dalton; thence in a southerly direction along the eastern side of such railway line to the eastern side of Millwood Bridge, by which the highway from Barrow to Dalton crosses such railway line; thence along the centre of that bridge and towards the southwest and south along the centre of such highway to its junction with Abbey-road; thence in a direction generally south-westerly along the centre of Abbey-road to the point of commencement.

NEWBARNS WARD.—The boundary of the Newbarns Ward shall be as follows:—

An imaginary line commencing at a point in the centre of Abbey-road where that road crosses the loop line of the Furness Railway, and extending thence along the south-eastern boundary of Hawcoat Ward to the eastern side of Millwood Bridge; thence along the east side of the main line of the Furness Railway from Barrow to Dalton in a direction generally southerly and south-westerly to the point where the north-eastern boundary of Salthouse Ward reaches such main line; and thence along the north-eastern boundaries of Salthouse and Central Wards, and along a portion of the north-eastern boundary of Ramsden Ward to the point of commencement.

YARLSIDE WARD.—The boundary of the Yarlside Ward shall comprise—

south-easterly direction to the point where an imaginary straight line drawn along the centre of Ramsden-street and across the ground intervening between such street and the loop line of Piel, Roe, and Foulney, Little Foulney and

Michael Island, Piel Harbour, and the portion of Piel Channel and all the waters, sands, scars, and marshes within the borough not included in Walney Ward.
