DECLARATION between Great Britain and Spain  
for the Protection of Trade Marks.

*Signed at London, December 14, 1875.*

THE Government of Her Majesty the Queen of the United Kingdom of Great Britain and Ireland, and the Government of His Majesty the King of Spain, with a view to the reciprocal protection of the marks of manufacture and trade in the two countries, have agreed as follows:—

The subjects of each of the Contracting Parties shall have in the dominions and possessions of the other, the same rights as belong to native subjects in everything relating to property in manufacturing or trade marks, industrial designs or patterns, or manufactures of any kind.

It is understood that any person who desires to obtain the aforesaid protection must fulfil the formalities required by the laws of the respective countries.

In witness whereof the undersigned have signed the present Declaration, and have affixed thereto the seal of their arms.

Done at London, the fourteenth day of December, 1875.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1869, (in this Order referred to as the Act of 1869,) and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. This Order shall take effect from and immediately after the twenty-third day of January,

one thousand eight hundred and seventy-six; and words in this Order have the same meaning as in the Act of 1869.

2. The Animals Order of 1875 shall be read and have effect as if Granton and Leith were not named in Article 71 or Article 85 of that Order.

3. The Orders described in the Schedule to this Order are hereby revoked.

4. Nothing in this Order shall be deemed to invalidate or make unlawful anything done under the said Orders, or either of them, before the date when this revocation takes effect, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the said Orders, or either of them.
