of the same wall on the north-western side of the road leading from the church of Saint James Mathon to Malvern and extending thence that is from the last-described boundary stone southward and in a direct line for a distance of three hundred and seventy-five yards or thereabouts thereby crossing the last-described road to the point at the south-eastern corner of North Hill Common upon the county boundary which divides the said new parish of Saint James Mathon from the new parish of the Holy Trinity Great Malvern aforesaid, at which last-mentioned point the boundaries of the original parishes of Cradley, Leigh, and Great Malvern all meet."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Worcester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of Her Majesty, chapter ninety-seven, of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; and of the Act of the thirty-fourth and thirty-fifth years of Her Majesty, chapter eighty-two; duly prepared and laid before Her Majesty in Council a representation, bearing date the twentieth day of January, in the year one thousand eight hundred and seventy-six, in the words and figures following; that is to say:—

"We the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty, chapter seventy, of the Act of the fourteenth and fifteenth years of your Majesty, chapter ninety-seven, of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, and of the Act of the thirty-fourth and thirty-fifth years of your Majesty, chapter eighty-two, have prepared and now humbly lay before your Majesty in Council, the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint John the Evangelist, situate at Hedge End, in the parish of Botley, in the county of Southampton, and in the diocese of Winchester.

"Whereas at certain extremities of the said parish of Botley and of the new parish of Saint James, West End in the said county of Southampton, and in the said diocese of Winchester, which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such parish and new parish respectively.

"And whereas it appears to us to be expedient that such contiguous portions of the said parish of Botley, and of the said new parish of Saint James, West End, should together with the whole of the contiguous extra-parochial place called or known as No Man's Land, in the said county of Southampton, and in the said diocese of Winchester, he formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint John the Evangelist situate at Hedge End as aforesaid.

"Now therefore, with the consent of Right Reverend Edward Harold Bishop of the said diocese of Winchester as such Bishop with the consent of the Reverend John Morley Lee the rector or incumbent and also the patron of the rectory of the said parish of Botley as such patron of the same rectory, and with the consent of the Reverend Albert Basil Orme Wilberforce the rector or incumbent of the rectory of the parish of Saint Mary Southampton in the said diocese of Winchester and as such rector or incumbent, the patron of the vicarage of the said new parish of Saint James, West End (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said parish of Botley and of the said new parish of Saint James, West End together with the whole of the said contiguous extra-parochial place called or known as No Man's Land which are described in the schedule hereunder written, and together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint John the Evangelist situate at Hedge End as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint John the Evangelist, Hedge End.'
"We, therefore, humbly pray that your Majesty

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to your Majesty in your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint John the Evangelist Hedge End being:—

"All those several contiguous portions of the parish of Botley as now defined for ecclesiastical purposes and of the new parish of Saint James West End both in the county of Southampton and in the diocese of Winchester and also all that contiguous extra-parochial territory in the said county and diocese containing by admeasurement one acre and a quarter or thereabouts which is called or known as No Man's Land and which is situate on the eastern side of the road leading from Hedge End to Bursledon at a distance (measured in a straight line) of about twenty-seven chains to the south of the church of Saint John the Evangelist, Hedge End all which said portions of such parish and new parish together with the extra-parochial territory aforesaid are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the new parish of Saint Mary, Scholing, in the said county and diocese from the new parish of Saint James, West End aforesaid, at the point at the north-eastern corner of Netley Common in the road leading from Bursledon to West End and extending thence that is from the said boundary northwestward for a distance of three-quarters of a
