The light is a *fixed and flashing* white light, showing a flash *every minute*, visible seaward when bearing from N.E. by E. $\frac{1}{2}$ E. to S.W. by W. $\frac{1}{2}$ W. It is elevated 78 feet above the level of high water, and in clear weather should be seen from a distance of 15 miles.

The illuminating apparatus is dioptric or by lenses, of the first order.

The lighthouse is in 12 feet at low water spring tides. Position, as given, lat. $16^{\circ} 16' N.$, long. $96^{\circ} 10' 40'' E.$; or adapted to present chart, lat. $16^{\circ} 15' 30'' N.$, long. $96^{\circ} 9' 20'' E.$

Also, that the temporary light-vessel has been removed.

(2.) *Fixed Light on Oyster Reef.*

Also, that from the 1st May, 1876, a light would be exhibited from a screw-pile lighthouse recently erected on Oyster Reef.

The light is a *fixed* white light, elevated 77 feet above the level of high water, and in clear weather should be seen from a distance of 15 miles.

The illuminating apparatus is dioptric or by lenses, of the second order.

The lighthouse is erected on screw piles in 4 fathoms at low water spring tides. Position, lat. $20^{\circ} 5' N.$, long. $92^{\circ} 39' E.$

HINDOSTAN, WEST COAST.

(3.) *Fixed Light at Verawal.*

Also, that since the 5th March, 1876, a light has been exhibited at Verawal.

The light is a *fixed* white light, elevated 56 feet above the level of high water, and in clear weather should be visible over an arc of 180° from a distance of 13 miles.

The illuminating apparatus is dioptric or by lenses, of the fourth order.

The lighthouse, 40 feet high, is built of stonewall and is situated on the pier head on the north-west side of the harbour. Position, lat. $20^{\circ} 53' 30'' N.$, long. $70^{\circ} 22' E.$

[All bearings are magnetic. Variations $2\frac{1}{2}^{\circ}$ easterly in 1876.]

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant and convey to the Incumbent of the vicarage of Tuxlith, otherwise Tuxleaf, otherwise Milland, in the county of Sussex, and in the diocese of Chichester, and to his successors, Incumbents of the same vicarage, all and singular the annual tithe commutation rent-charges which are particularly described in the schedule hereunto annexed, and are now vested in us, to have and to hold the said annual tithe commutation rent-charges to the use of the said Incumbent and his successors for ever: Provided always, that the Incumbent for the time being of the same vicarage shall be entitled to receive from us, or on our account, the net amount of the profits and proceeds of the said annual tithe commutation rent-charges, for and in respect of the period intervening between the twenty-third day of March, in the year one thousand eight hundred and seventy-five, and the date of the publication of these presents in the London Gazette.
