

charges, amounting together to forty-four pounds, which have been permanently secured to the vicarage or benefice of Ystradffin, in the county of Carmarthen, and in the diocese of St. Davids, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant to the Incumbent of the said vicarage or benefice of Ystradffin, and to his successors, to meet such benefaction, one yearly sum or stipend of twenty-two pounds and two shillings, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the said yearly sum or stipend or any part thereof, shall be annexed by us to the said vicarage or benefice, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant and convey to the Incumbent of the vicarage of Seend, in the county of Wilts, and in the diocese of Salisbury, and to his successors, Incumbents of the same vicarage, all that messuage or tenement, piece or parcel of land and hereditaments, together with the appurtenances thereunto belonging, which said tenement, parcel of land, and hereditaments are particularly described in the schedule hereunto annexed, and are now vested in us: To have and to hold the said messuage or tenement, piece or parcel of land and other hereditaments, with their appurtenances, to the use of the said Incumbent and his successors for ever: Provided always, that the Incumbent for the time being of the same vicarage shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said messuage, parcel of land, and other hereditaments for and in respect of the period intervening between the first day of May, in the year one thousand eight hundred and seventy-six, and the date of the publication of these presents in the London Gazette.

Firstly. All that messuage or tenement, the site of which was formerly occupied by a farm-house, called or known by the name of Somners, situate at Seend, in the county of Wilts, with the barn, stable-yard, back side outhouses, and gardens thereto adjoining and belonging, and now in the occupation of the Reverend Arthur Barugh Thynne, as tenant thereof, and which together

with the hereditaments next hereinafter described, contain one acre, more or less.

Secondly. All that plot of ground abutting upon the above-mentioned premises and upon a lane, called Hilliers-lane, and containing about sixteen perches, more or less, together with a right of way of the length of thirteen yards and of the width of eight feet, leading from the back garden gate of the premises firstly hereinbefore described, across property belonging to Wadham Locke, of Cleve House, Seend, Esquire, to the said plot of ground secondly hereinbefore described, in the direction marked by dotted lines in the plan hereunto annexed; and all which premises hereinbefore referred to are more particularly delineated on the said plan, and are therein distinguished by the colours red and yellow respectively.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent of the vicarage of Shaw, otherwise Shaw and Whitley, in the county of Wilts, and in the diocese of Salisbury, and to his successors, Incumbents of the same vicarage, one yearly sum or stipend of one hundred and forty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the first day of May, in the year one thousand eight hundred and seventy-six, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments, sufficient, in our opinion, to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction, consisting of two hundred and fifty pounds sterling, which has been applied in purchasing, for the benefice of Saint Barnabas, Rotherhithe, in the county of Surrey, and in the diocese of Winchester, of a certain house and premises, approved by us as a parsonage or house of residence for the said benefice, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said benefice of Saint Barnabas, Rotherhithe, to meet such benefaction, one other capital sum of two hundred and fifty pounds sterling, to be applied in like manner, and to remain in the meantime in our hands at interest after the rate of three pounds per centum per annum, and such interest to be paid to the Incumbent for the time being of the said benefice of Saint Barnabas, Rotherhithe.
