*At the Court at Windsor, July 12, 1876.*

**T**HE Queen, as Sovereign of the Most Noble Order of the Garter, has been graciously pleased, by Letters Patent under Her Royal Sign Manual and the Great Seal of the Order, bearing date this day, to dispense with all the Statutes and regulations usually observed in regard to Installation, and to grant unto His Majesty George I, King of the Hellenes, Knight of the said Most Noble Order, and duly invested with the Ensigns thereof, full power and authority to exercise all rights and privileges belonging to a Knight Companion of the Most Noble Order of the Garter, in us full and ample a manner as if His Majesty had been formally installed, any decree, rule, or usage to the contrary notwithstanding.

(commonly called the Honourable Wilbraham Egerton) ; James Cochran Stevenson, Esq. ; Frederick Augustus Abel, Esq., President of the Chemical Society ; Alexander William Williamson, Esq., Professor of Chemistry and Practical Chemistry at University College, London ; Henry Enfield Roscoe, Esq., Professor of Chemistry at Owen's College, Manchester ; and William Windham Hornby, Esq., a Vice-Admiral on the Retired List of Her Majesty's Fleet, to be Her Majesty's Commissioners to enquire into the working and manage-

ment of Works and Manufactories from which sulphurous acid, sulphuretted hydrogen, and ammoniacal or other vapours and gases are given off, to ascertain the effect produced thereby on animal and vegetable life, and to report on the means to be adopted for the prevention of injury thereto, arising from the exhalations of such acids, vapours, and gases.
