To which audiences they were respectively introduced by the Earl of Derby, Her Majesty's Principal Secretary of State for Foreign Affairs.

Board of Trade (Harbour Department), Whitehall Gardens, July 31, 1876.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Telegram from Her Majesty's Ambassador at Constantinople, stating that the plague had ceased at Baghdad, and that in consequence of the improved state of health in Mesopotamia quarantine in Turkish and Egyptian ports is reduced to five days, with the exception of arrivals from Bushire, which are still subject to fifteen days.
