towns, and to the increase of the health and com-

fort of my people.

The serious evils arising from the Pollution of Rivers have long been the subject of public complaint, and I rejoice that you have passed a measure which, by checking those evils, will improve the sanitary condition of the country.

I have observed with much satisfaction the arrangements which you have made for maintaining and increasing the efficiency of the Tribunal of Ultimate Appeal for the United Kingdom, by which, at the same time, the Judicial Committee of my Privy Council and my intermediate Court of Appeal will be improved and strengthened.

I anticipate the best results from the Act which you have passed providing safeguards against painful experiments upon Living Animals.

I regret that pressure of other business has prevented the completion of your labours upon several measures of much importance. Among these I specially notice the Bills relating to the Universities of Oxford and Cambridge, to the Administration of Prisons, and to the Law affecting Maritime Contracts. I trust, however, that the attention which you have given to these questions in the past session may facilitate their settlement in

In bidding you farewell, I pray that the blessing of Providence may rest on your recent labours, and accompany you in the discharge of all your duties.

> BISHOPSTOKE.—Forthwith wholly in the parish church of Bishopstoke; and in the churchyard except in vaults and walled graves, in which each coffin shall be separately enclosed by stonework or brickwork properly cemented, and except in earthen graves not less than four feet deep which can be opened without exposing other coffins or disturbing entire bones.
