A Letter directed to the Lord Pre-fident from the Lord Livingfoune was read in the Meeting, giving an account of the Caufes of his retiring from Edinburg at this time. Another Letter from the Viccount of Dundee to the fame purpofe, was likewife read. An Act approving the good fervice of fuch Med from Argyle, Glafgow, and the We-ftern Shires, as were in Arms and kept Guard in Edinburg, under the Command of the Earl of Levin, fince the meeting of the Eltates, with an allowance to fuch of them as have not Lifted themfelves in the Earl's Regiment, to return with their Arms to their refpective Homes, was brought in, Confi-dered, and Approven. A Letter from the Earl of *Pearth* defining fome Perfons and Servants might be allowed Access to him in the Caffle of Striveling, was read; and his Or-dinary Servants were allowed to ftay with him. Ordered, That the Earl of Growford, & c. do fee the Magistrates of Edenburg give their Oathsof Fidelity to the Effates this After-noon. The Houfe Adjourned till Saturday. And the Commattee for fetling the Kingdom is to lit in the mean time.
