AS it is has come to the knowledge of the Government, that certain Consuls of the Republic in England erroneously interpreting the Consular Tariff, have charged Consular Fees for legalising bills of lading and certificates of origin of goods, His Excellency the Provisional Governor has determined upon settling this point, deciding that such documents shall only be legalised in cases when the parties interested so require.

If any of the Consuls or Vice-Consuls within your jurisdiction shall have exacted these dues, he should make restitution of the amount received, advertising to that effect for the information of those interested.

In addition you will desire all your subordinates that they shall state, at the foot of documents certified, the Consular fee charged in accordance

with the Tariff.
