which consent he hath set his hand and affixed his seal to this scheme) we the said Ecclesiastical Commissioners humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said benefice of Sutton and the church thereof shall be assigned and transferred from the said William Connor Bishop of the said diocese of Peterborough (in whom as aforesaid it is now vested) and from his successors Bishops of the same diocese and shall become and be absolutely vested in and shall and may from time to time and at all times be exercised by the said William Hopkinson his heirs and assigns for ever and that in exchange for the same the whole advowson or perpetual right of patronage of and

presentation to the said benefice of Thorpe Saint Peter and the church thereof save and except only the next turn of presentation to the same benefice and the church thereof shall in like manner upon and from the day aforesaid be assigned and transferred from the said William Hopkinson (in whom as aforesaid it is now vested) and from his heirs and assigns and shall become and be absolutely vested in and shall and may from time to time and at all times be exercised by the said William Connor Bishop of the said diocese of Peterborough and by his successors Bishops of the same diocese for ever.

"And, we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parliament.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; and of the Act of the thirty-fourth and thirty-fifth years of Her Majesty, chapter eighty-two; duly prepared and laid before Her Majesty in Council a representation, bearing date the eighteenth day of January, in the year one

thousand eight hundred and seventy-seven in the words and figures following ; that is to say :---

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the eighth and ninth years of your Majesty chapter seventy, of the Act of the nineteenth and twentieth years of your Majesty chapter fifty-five, and of the Act of the thirty-fourth and thirtyfifth years of your Majesty chapter eighty-two have prepared and now humbly lay before your Majesty in Council, the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint James situate at Newton Hall, in the parish of Bywell Saint Peter in the county of Northumberland and in the diocese of Durham.

"Wherens at certain extremities of the said parish of Bywell Saint Peter, of the parish of Bywell Saint Andrew, of the parish of Ovingham and of the parish of Corbridge, all in the county and diocese aforesaid which said extremitics lie contiguous one to another and are described in the schedule hereunder written there is collected together a population which is situate at a distance from the several churches of the said parishes.

"And whereas it appears to us to be expedient" that such contiguous portions of the said parish of Bywell Saint Peter, of the said parish of Bywell Saint Andrew, of the said parish of Ovingham and of the said parish of Corbridge should be formed into a consolidated chapelry for all ecclesiastical purposes and that the same should be
