W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen, of the Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, of the Act of the nineteenth and twentieth years of Her Majesty, chapter one hundred and four, and of the Act of the twentythird and twenty-fourth years of Her Majesty; chapter one hundred and twenty-four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-second day of March, in the year one thousand eight hundred and seventyseven in the words following, that is to say ; "We the Ecclesiastical Commissioners for

England in pursuance of the Act of the third and fourth years of your Majesty chapter one hundred and thirteen of the Act of the sixth and seventh years of your Majesty chapter thirty-seven, of the Act of the nineteenth and twentieth years of your Majesty chapter one hundred and four and of the Act of the twenty-third and fourth years of your Majesty chapter one hundred and twentyfour, have prepared and now humbly lay before your Majesty in Council, the following scheme for constituting a separate district for spiritual pur-poses out of the new parish of Saint John Angell Town, out of the new parish of Saint Jude East Brixton and out of the district parish of Saint Matthew Brixton, all which three cures originally formed part of the parish of Lambeth in the county of Surrey and in the diocese of Winchester.

"Whereas it has been made to appear to us that it would promote the interests of religion that the particular portions of the said new parish of Saint John Angell Town of the said new parish of Saint Jude East Brixton and of the said district parish of Saint Matthew Brixton which are hereinafter mentioned and described should be constituted a separate district in the manner hereinafter set forth.

"And whereas there is not at present within the limits of the said proposed district any consecrated church or chapel in use for the purposes of Divine worship.

"And whereas certain hereditaments and premises situate within the said parish of Lambeth have become vested in us under the provisions of and for the purposes of the herein-mentioned Acts or of some of them and we have in respect of such hereditaments and premises agreed to make and pay out of the common fund created by the firstly herein-mentioned Act to the minister of the district hereinafter recommended to be constituted, so soon as one shall have been duly licensed in accordance with the provisions of the secondly herein-mentioned Act and to his successors a grant of two hundred pounds per annum and also so soon as a church shall have been erected within and for such district, and shall have been approved by us and shall have been consecrated as the church of such district and such district shall have thereupon become a new parish within the meaning of the secondly herein-mentioned Act to make and pay such further grant from the said fund as will suffice to raise the income of the incumbent of the said new parish to three hundred pounds per annum.

"And whereas such grants as aforesaid will be made by an instrument or instruments to be executed by us under our common seal in accordance with the provisions of the Act of the twentyninth and thirtieth years of your Majesty chapter one hundred and eleven.

"Now therefore with the consent of the Right Reverend Edward Harold Bishop of the said diocese of Winchester (in testimony whereof he has signed and sealed this scheme) we humbly recommend and propose that all those portions of the said new parish of Saint John Angell Town, of the said new parish of Saint Jude East Brixton, and of the said district parish of Saint Matthew Brixton, which are mentioned and described in the schedule hereunder written and which are delineated and set forth on the map or plan hereunto annexed, shall upon and from the day of the
