described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint John the Evangelist situate in the Leigh-road as aforesaid, and that the same should be named 'The District Chapelry of Saint John the Evangelist, New

Borough and Leigh.

"And with the like consent of the said George, Bishop of the said diocese of Salisbury (testified as aforesaid), we the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint John the Evangelist situate in the Leigh-road as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that so long as any one of the persons who are now priest vicars or incumbents of the benefice of the said parish of Wimborne Minster shall continue to be such priest vicar or incumbent all the fees which may be received in respect of such publication, solemnization or performance at the said church of Saint John the Evangelist, situate in the Leighroad as aforesaid, shall be paid over by the minister thereof to the said priest vicars or incumbents and each of them in the proportions which may be due to them or him respectively; and provided also that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the

registration thereof.
"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

## "The SCHEDULE to the foregoing Representation has reference.

"The District Chapelry of Saint John the Evangelist New Borough and Leigh being :-

"All that part of the parish of Wimborne Minster in the county of Dorset, and in the diocese of Salisbury, which is bounded on the east by the parish of Hampreston in the said county and diocese, on the south by the parish of Canford Magna in the same county and diocese, and on all other sides, that is to say, on the west and on the north by an imaginary line commencing upon the boundary which divides the last-named parish from the parish of Wimborne Minster atoresaid at the centre of Canford Bridge which carries the Poole-road over the River Stour, and extending thence for a distance of thirty-nine chains or thereabouts first northward and then northwestward along the middle of the said Poole-road to its junction at Poole-corner with the Leighroad and extending thence eastward for a distance of twenty chains or thereabouts, along the middle of the last-named road to its junction on the western side of the church of Saint John the Evangelist, with 'Leg-lane' and extending thence northward for a distance of twenty-one chains or thereabouts along the middle of the said lane and along the middle of the public footpath leading from the said Leg-lane into Bullpits-road, to the junction of the said public footpath with Bullpits-road aforesaid and extending thence north-east-

ward for a distance of thirty-four chains or thereabouts along the middle of the last-named road to its junction at or near to the house called or known as Weymans with the road leading from Longlane past Greenhill to Leigh and extending thence southward for a distance of six chains or thereabouts along the middle of the last-described road to its junction with the road leading from Wimborne to Little Lonnen and extending thence northeastward for a distance of fifty-three chains or thereabouts along the middle of the last-described road to the boundary at or near to the house called or known as 'Eltons' which boundary divides the said parish of Wimborne Minster from the parish of Hampreston aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Salisbury.

The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirty-second and thirty-third years of Her Majesty, chapter ninety-four, duly prepared and laid before Her Majesty in Council a scheme or representation bearing date the twenty-second day of March, in the year one thousand eight hundred and seventy-seven, in the words following; that is to

say:-"We the Ecclesiastical Commissioners for England acting under the provisions of the Act of the thirty-second and thirty-third years of your Majesty chapter ninety-four have prepared and now humbly lay before your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Much Woolton sometime part of the parish of Childwall in the county of Lancaster and in the diocese of Chester.

"Whereas by the authority of an Order of your Majesty in Council bearing date the fifteenth day of January in the year one thousand eight hundred and twenty-eight and published in the London Gazette upon the fourth day of July in the same year a portion of the said parish of Childwall was assigned as a separate district to the consecrated church situate at Much Woolton within the limits of the same parish and was called 'The Chapelry District of Much Woolton.'

"And whereas the said chapelry district of Much Woolton has under the provisions of the Act of the nineteenth and twentieth years of your Majesty chapter one hundred and four since become a new parish of the character contemplated by that Act and by the Act of the sixth and seventh years of your Majesty chapter thirtyseven and by the said Act of the thirty-second and thirty-third years of your Majesty chapter ninety-
