Belfast Central Railway (Extensions) Bill.  
(Alterations of Works during Progress of Bill through the House of Lords.)

**N**OTICE is hereby given, that during the progress through the House of Lords of the Bill introduced into Parliament in the present session under the above name or short title, an alteration has been or will be made in the work originally proposed to be authorised by the said Bill, and that the only work which it is now intended that the said Bill should authorise is a railway or tramway one furlong one chain and fourteen yards or thereabouts in length, wholly in the townland of Town Parks, in the parish of Shankhill, otherwise Belfast, in the county of Antrim, commencing by a junction with the existing line, the Belfast Central Railway Company's Railway, which passes through their goods shed at Oxford-street, at a point about ten yards south-eastward from the southern end of that shed, and terminating on Donegal Quay, at a point not being less than one hundred feet or more than one hundred and two feet northward of the centre line of the roadway of the Queen's Bridge.

Plans and sections of such alteration of works, showing the line and levels of the said railway or tramway, together with books of reference to such plans, have been deposited with the Clerk of the Peace for the county of Antrim, at his office at Belfast, in that county, and with the Clerk of the Poor Law Union of Belfast, within which union the said parish of Shankhill, otherwise Belfast, is included.

Tramway Bye-laws and Regulations.

**N**OTICE is hereby given, that the Mayor, Aldermen, and Burgesses of the said borough of Sheffield, acting by the Council of such borough, being the local authority for the said borough, under and for the purposes of "The Tramways Act, 1870," and being also the Promoters of the tramways authorized to be made by "The Sheffield Tramways Act, 1872," at a meeting of the said Council, duly convened and held on Wednesday, the 9th day of May instant, did, in pursuance of the powers to them for that purpose given in and by the 46th section of the said "Tramways Act, 1870," and of every other power enabling them in that behalf make, order, and ordain the following Bye-laws and Regulations for preventing the commission of any nuisance in or upon any carriage belonging to the Sheffield Tramways Company, and for regulating the travelling in or upon any such carriage, viz. :—

The Bye-laws and Regulations hereinafter set forth shall be deemed to be the Rules and Regulations which the Mayor, Aldermen, and Burgesses of the borough of Sheffield as the Local Authority, and also as the Promoters, and the Sheffield Tramways Company as the Lessees are entitled to make under and by virtue of the Tramways Act, 1870, section 46, and shall extend and apply to all carriages of the Company, and to all
