WE, the Ecclesiastical Commissioners for England, partly in consideration of a benefaction of four hundred and thirty pounds sterling, which has been paid to us in favour of the vicarage of Downe, in the county of Kent, and in the diocese of Canterbury, do hereby in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, but subject as hereinafter mentioned, grant and convey to the Incumbent for the time being of the said vicarage of Downe, and to his successors, Incumbents of the same vicarage, all and singular the yearly tithe commutation rent-charges which are set out in the schedule hereunto annexed, and now vested in us: To have and to hold the said yearly tithe commutation rent-charges to the use of the said Incumbent and his successors for ever: Provided always that the said yearly tithe commutation rent-charges expressed to be hereby granted and conveyed shall be and be taken to be in lieu of and in full substitution for the sum of four hundred and thirty pounds sterling hereinbefore referred to: And provided also, that the Incumbent for the time being of the said vicarage shall be entitled to receive from us, or on our account, the net amount of the profits and proceeds of the said yearly tithe commutation rent-charges for and in respect of the period intervening between the first day of April, one thousand eight hundred and seventy-seven, and the date of the publication of these presents in the London Gazette.
