WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of five hundred pounds sterling, which has been paid to us in favour of the vicarage of East Retford, in the county of Nottingham, and in the diocese of Lincoln, and in respect of which we have agreed to pay to the Incumbent of the same vicarage, and to his successors, a yearly sum of sixteen pounds thirteen shillings and four pence, do hereby, in pursuance of the Act of the twentyninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant to the Incumbent of the said vicarage of East Retford, and to his successors, to meet such benefaction, one other yearly sum or stipend of sixteen pounds thirteen shillings and four pence, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year : Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the yearly sum or stipend, so payable out of our common fund, as lastly herein
