WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction, consisting of five hundred pounds sterling, which has been paid to us in favour of the vicarage of Saint John's-juxta-Swansea, in the county of Glamorgan, and in the diocese of Saint David's, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said vicarage of Saint John's-juxta-Swansea, to meet such benefaction, one other capital sum of five hundred pounds sterling, to be applicable towards defraying the cost of providing a parsonage or house of residence for the said vicarage, according to plans and a specification approved or to be approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands at interest after the rate of three pounds per centum per annum, and such interest to be paid to the Incumbent for the time being of the said vicarage of Saint John's-juxta-Swansea.

In witness whereof, we have hereunto set our common seal, this seventeenth day of May, in the year one thousand eight hundred and seventy-seven.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent of the rectory of Weeke, otherwise Wyke, in the county of Southampton, and in the diocese of Winchester, and to his successors, Incumbents of the same rectory, one yearly sum or stipend of seventeen pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the twenty-ninth day of September, in the year one thousand

eight hundred and seventy-six, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said rectory, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.
