THE Queen has been graciously pleased to order a Writ to be issued under the Great Seal of the United Kingdom of Great Britain and Ireland for summoning Alfred Joseph, Baron Stourton, of Stourton, in the county of Wilts, to the House of Peers by the name, style, and title of Baron Mowbray, he being one of the heirs of Roger de Mowbray, who was summoned to Parliament in the eleventh year of the reign of King Edward the First.
