THE Queen has been pleased to direct Letters Patent to be passed under the Great Seal of the United Kingdom of Great Britain and Ireland declaring that Alfred Joseph, Baron Stourton, of Stourton, in the county of Wilts, one of the co-heirs of Edward, Duke of Norfolk, and Baron Segrave, and as such one of the co-heirs of Nicholas de Segrave, who was summoned to Parliament by Writ in the eleventh year of the reign of King Edward the First, shall be Baron Segrave, and shall have and enjoy the ancient Barony of Segrave, together with all the rights, titles, privileges, pre-eminences, immunities, precedence, and advantages thereunto belonging, or in anywise appertaining, to hold to him and the heirs of his body in as full and ample manner as the said Edward, Duke of Norfolk, the last Baron Segrave, or any of his ancestors, Barons Segrave, held and enjoyed the same.
