And whereas the said representation has been i approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forth-with registered by the Registrar of the said diocese of Salisbury.

## PRESENT.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of Her Majesty, chapter ninetyseven; of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; and of the Act of the thirty-fourth and thirty-fifth years of Her Majesty, chapter eighty-two; duly prepared and laid before Her Majesty in Council, a representation, bearing date the twenty-second day of November in the year one thousand eight hundred and seventy-seven in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty, chapter seventy, of the Act of the fourteenth and fifteenth years of your Majesty, chapter ninety-seven, of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, and of the Act of the thirty-fourth and thirty-fifth years of your Ma-jesty, chapter eighty-two, have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint John the Evangelist situate at Abbey Dale in the parish of Dore in the county of Derby and in the diocese of Lichfield.

"Whereas at certain extremities of the said parish of Dore and of the parish of Norton, in the said county of Derby, and the said diocese of Lichfield which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such respective parishes.

And whereas it appears to us to be expedient that such contiguous portions of the said parish of Dore and of the said parish of Norton should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint John the Evangelist situate at Abbey Dale as aforesaid.

Now, therefore, with the consent of the Right Reverend George Augustus Bishop of the said diocese of Lichfield as such Bishop with the consent of the Right Honourable William Thomas Spencer, Earl Fitzwilliam, Knight of the Most Noble Order of the Garter, who is the patron of the vicarage of the said parish of Dore, and with the consent of William Challinor, of Leek, in the county of Stafford, Esquire, of Thomas Shaw, also of Leek aforesaid, Esquire, of Henry Mort-

Chester Esquire, and of William Edward Challinor of Pickwood near Leek aforesaid, Esquire, who are, or some of whom are, the patrons of, or the persons who are now entitled upon any vacancy to present an incumbent to, the vicarage of the said parish of Norton (in testimony whereof they the said consenting parties have respectively signed and scaled this representation) we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said parish of Dore and of the said parish of Norton which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint John the Evangelist situate at Abbey Dale as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint John Abbey Dale.

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to your Majesty in your

Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint John Abbey Dale being :-

"All that portion of the parish of Dore in the county of Derby and in the diocese of Lichfield which is bounded on the north by the county of York on the east partly by the extra-parochial territory called or known as the liberty of Beauchief and partly by the parish of Norton both in the said county of Derby and in the diocese of Lichfield aforesaid on the south partly by the parish of Dronfield and partly by the parish of Holmesfield both in the last-mentioned county and diocese and upon the remaining side, that is to say, the west by an imaginary line commencing upon the boundary which divides the last-named parish from the parish of Dore aforesaid at the point in the middle of Totley Brook where it is crossed by the bridle-road leading from Holmesfield to Totley such point being opposite to a boundary-stone inscribed 'A. St. J. C. C. 1877 No. 1' and placed on the northern side of the said brook and extending thence that is from the said point northward to the said boundary-stone and continuing thence still northward and in a direct line for a distance of twenty-nine and a half chains or thereabouts to a boundary-stone inscribed 'A. St. J. C. C. 1877 No. 2' and placed at the western angle formed by the junction of Mickley-lane with the turnpikeroad leading from Baslow to Sheffield, and extending thence first northward to a point in the middle of the said turnpike-road and then westward for a distance of thirty yards or thereabouts, along the middle of the same turnpike road to the Green Oak turnpike-gate and extending thence northwestward and in a direct line for a distance of twenty-four and a half chains or thereabouts to the southern end of the weir in Oldhay Brook near to the western end of the new road on the Totley Brook estate and extending thence northeastward and in a direct line for a distance of sixty-two and a half-chains or thereabouts to a boundary-stone inscribed 'A. St. J. C. C. 1877 No. 3' and placed on the western side of Dorelane at the point where the same lane bends sharply to the north such point being distant about ten chains to the west of Ashfurlong cottages and extending thence first eastward for a lock Fernie, of Macclesfield in the county of distance of ten chains or thereabouts along the
