Camden (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said district parish of Saint George Camberwell, and of the said particular district of Camden which are described in the schedule hereunder written, all which portions together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Luke situate in Rosemary-road, Peckham as aforesaid and that the same should be named 'The Consolidated Chapelry of Saint Luke Camberwell.'

"We therefore, humbly pray that your Majesty will be graciously pleased to take the promises into your Royal consideration, and to make such Order in respect thereto as to your Majesty in your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Luke,

Camberwell, being :-

"All that portion of the district parish of Saint George Camberwell, in the county of Surrey and in the diocese of Rochester which is bounded on the east, on the south, and on the south-west by the particular district of Camden in the county and diocese aforesaid and upon all other sides that is to say on the west and on the north by an imaginary line commencing upon the boundary which divides the said particular district of Camden from the district parish of Saint George Camberwell aforesaid at the point where Southamptonstreet is joined by Diamond-street and extending thence north-eastward along the middle of the last-named street for a distance of three and three-quarter chains or thereabouts to its junction with Blake's-road and extending thence first north-westward for a distance of nine chains or thereabouts along the middle of the last-named road and then north-eastward for a distance of three and a half chains or thereabouts along the middle of the same road to its junction with Grayland's-road and extending thence north-westward along the middle of the last-named road for a distance of six chains or thereabouts to its junction with Fendick-road and extending thence northeastward along the middle of the last-named road for a distance of two and a half chains or thereabouts to its junction with Castlemaine-road and extending thence northward along the middle of the last-named road for a distance of three chains or thereabouts to its junction with Gloucesterroad and with Albert-street and continuing thence still northward for a distance of five chains and a half or thereabouts across the said Gloucesterroad and along the middle of Albert-street aforesaid to the junction of the last-named street with Saint George's-road and extending thence eastward along the middle of the last-named road for a distance of a quarter of a mile or thereabouts to the boundary at the junction of the same road with Sumner-road which boundary divides the said district parish of Saint George Camberwell from the particular district of Camden aforesaid.

"And also all that contiguous portion of the said particular district of Camden which is bounded on the west by the district parish of Saint George Camberwell aforesaid and on the remaining sides that is to say on the north-east and on the south by an imaginary line commencing at the point at or near to the junction of Sumner-

road aforesaid with Alder-street where the boundary which divides the said two cures commences to diverge from the middle of the said Sumnerroad and extending thence that is from the said boundary southward along the middle of the same road for a distance of twenty-one chains or thereabouts to its junction with Commercial-road and extending thence westward along the northern side of the last-named road for a distance of three chains and a half or thereabouts to the boundary divides the said particular district of Camden from the district parish of Saint George Camberwell aforesaid."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Rochester.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirteenth and fourteenth years of Her Majesty, chapter forty-one, and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-eighth day of March, in the year one thousand eight hundred and seventy-eight, in the words following that is to say:

words following, that is to say:

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the thirteenth and fourteenth years of your Majesty chapter forty-one and of the Act of the nineteenth and twentieth years of your Majesty chapter fifty-five have prepared and now humbly lay before your Majesty in Council the following scheme for setting out and constituting a district for spiritual purposes and annexing such district to the consecrated church of Saint Paul situate at Heaton Moor within the limits of the new parish of Heaton Norris (some-time part of the original parish of Manchester) in the county of Lancaster and in the diocese of Manchester.

"Whereas it appears to us to be expedient that a district for spiritual purposes should be set out and constituted for and annexed to the said church of Saint Paul situate at Heaton Moor as aforesaid.

"Now therefore with the consent of the Right Reverend James Bishop of the said diocese of Manchester testified by his having signed and sealed this scheme we humbly recommend and propose that all that portion of the said new parish of Heaton Norris and also all that contiguous portion of the new parish of Saint John Heaton Mersey (also sometime part of the original parish of Manchester aforesaid) all which portions are described in the schedule hereunder written and are delineated and set forth on the map or plan hereunto annexed shall upon and from the day of the date
