The Queen has been pleased to grant unto George Gery Milner-Gibson, of Hardwick House, in the parish of Hardwick, near Bury St. Edmunds, in the county of Suffolk, Gentleman, second son of the Right Honourable Thomas Milner-Gibson, of Theberton House, in the parish of Theberton, near Saxmundham, in the said county, by Susannah Arethusa, his wife, only child of Sir Thomas Gery Cullum, late of Hardwick House aforesaid, Baronet, Clerk in Holy Orders, deceased, Her Royal licence and authority that he may, in compliance with a clause contained in the last will and testament of Dame Anne Cullum, late of Hardwick House aforesaid, the widow and relict of the said Sir Thomas Gery Cullum, take and henceforth use the surname of Cullum in addition to and after those of Milner-Gibson, and also bear the arms of Cullum quarterly with his own family arms; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms. Admiralty, 10th December, 1878.

5th Dragoon Guards, Lieutenant Frederick Wilson Hemming, from the 4th Hussars, to be Captain, vice R. W. Kearsley, seconded from 1st October, 1878, for service as an Adjutant of Auxiliary Forces. Dated 31st October, 1878, such antedate not to carry back pay prior to the 14th December, 1878.
