scribed by this Act to be taken respecting a Statule made by the Commissioners after (but not before) the Statute is made, be deemed to be a Statute made by the Commissioners.'

"And whereas it is expedient to amend the Statutes of Worcester College Oxford so far as they relate to the Fellowship held by the Bursar of the said College.

"We the Provost and Fellows of Worcester College in the University of Oxford being the governing body of the said College within the meaning of the said Act in the exercise of the powers conferred on us by the eleventh clause above recited of the said Act at a general meeting of the said College holden the eighth day of October in the year of our Lord one thousand eight hundred and seventy-eight have made the following Statute that is to say :-

Any Fellow being Bursar who shall hereafter marry or who shall have been married before the approval of this Statute by Her Majesty in Council and whose year of grace may not have then expired may, if the College think fit, on the expiration of his year of grace, be re-elected to his fellowship by a majority of the votes of the Provost and Fellows present at any stated general meeting, and may thereafter hold the same notwithstanding his marriage. Provided that any such Fellow who shall cease to hold the office of. Bursar shall thereby vacate his fellowship.

"Given under our common seal this eighth day of October one thousand eight hundred and seventy-eight.
