if possible, be effected by means of a disinfecting oven, which shall be heated to 120° Celsius.

In the absence of this means, or where it cannot be applied, exposure during six hours to the funces of sulphur in a close room or space shall be used, in the proportion of one kvint (five grammes) of sulphur for every cubic ell (two Danish feet). Trunks and cases in which luggage has been packed shall be carefully washed with a solution of one part of chloride of zinc to fifty parts of water.

Sec. 7. This Notice comes into force immediately, and is hereby brought to the notice of the public.
