should be formed into a consolidated chapelry for all ecclesiastical purposes and that the same should be assigned to the said church of Saint Mark

situate at Heyside as aforesaid.

"Now therefore with the consent of the Right Reverend James Bishop of the said diocese of Manchester as such Bishop and also as one of the patrons of the vicarage of the said new parish of Saint Stephen and All Martyrs Lower Moor with the consent of Hilton Greaves of Oldham in the said county of Lancaster Esquire of Thomas. Hibbert Radcliffe of Oldham aforesaid Esquire and of Robert Stott of Oldham aforesaid Esquire as the remaining patrons of the said vicarage of the new parish of Saint Stephen and All Martyrs Lower Moor and with the consent of the Reverend Henry Mildred Birch a Canon of the Cathedral Church of Ripon and rector or incumbent of the rectory of the parish of Prestwich in the said diocese of Manchester as the patron (in right of his rectory or incumbency) of the vicarage of the said new parish of Royton (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we the said Ecclesiastical Commissioners for England humbly represent that it would in our opinion be expedient that all those contiguous portions of the said new parish of Royton and of the said new parish of Saint Stephen and All Martyrs Lower Moor which are described in the schedule hereunder written all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed should be united and formed into one consolidated chapelry for the said church of Saint Mark situate at Heyside as aforesaid and that the same should be named 'The Consolidated Chapelry of Saint Mark Heyside.'

"We therefore humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration and to make such Order in respect thereto as to your Majesty in your

Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Mark

Heyside being :-

"All that portion of the new parish of Royton in the county of Lancaster and in the diocese of Manchester, which is bounded on the north by the new parish of Crompton otherwise called or known as Shaw on the east partly by the new parish of Saint Thomas Moorside and partly by the new parish of Saint James Oldham on the south-east by the new parish of Saint Stephen and All Martyrs Lower Moor on the south by the new parish of Coldhurst all in the said county of Lancaster and in the diocese of Manchester aforesaid and on the remaining side that is to say on the west by an imaginary line commencing at the point where the boundary which divides the said new parish of Coldhurst from the new parish of Royton aforesaid crosses the middle of Booth Hill-lane and extending thence north-eastward along the middle of the said lane for a distance of twenty-five chains or thereabouts to its: junction at the house called or known as Higher Edge-lane with Edge-lane-road and continuing thence still north-eastward and in a direct line for a distance of twenty-six and a half chains or thereabouts to the centre of the bridge which carries Turf-lane over the line of the Royton Branch of the Lan-cashire and Yorkshire Railway and extending thence north-westward along the middle of the said branch line of railway for a distance of eighteen chains or thereabouts to the centre of the bridge which carries Shaw-road over the same

branch line of railway and extending thence north-eastward along the middle of the lastnamed road for a distance of twenty-seven chains or thereabouts to its junction at the house called, or known as Luzley Brook with Park-lane and extending thence first north-westward and thenwestward along the middle of the last-named lane. for a distance of three and a half chains or thereabouts to the point where it crosses the stream. called or known as the Irk and extending thence first northward and then north-eastward along the middle of the said stream for a distance of eleven chains or thereabouts (thereby passing close along the western side of the Luzley Brook Cotton Mill) to the boundary which divides the said new parish of Royton from the new parish of Crompton otherwise called or known as Shaw aforesaid...

"And also all that contiguous portion of the new parish of Saint Stephen and All Martyrs Lower Moor aforesaid which is bounded on the east by the said new parish of Saint James Oldham, on the north and on the north-west by the hereinbefore described portion of the said new parish of Royton, on the south-west by the new parish of Coldhurst aforesaid and upon the remaining side that is to say upon the south by an imaginary line commencing upon the boundary which divides the said new parish of Coldhurst from the new parish of Saint Stephen and All Martyrs Lower Moor aforesaid at the point where Potter-lane is joined by the footpath leading to to Roughs-lane and extending thence south-eastward along the middle of the said Potter-lane for a distance of two chains or thereabouts to its junction with the lane or footway leading past the southern side of the houses called or known as Higher Moor across Higginshaw New-road into Stampstone-lane and extending thence first northeastward and then eastward along the middle of the last-described lane or footway for a distance of eighteen chains or thereabouts (thereby crossing Higginshaw New-road aforesaid) to the boundary at the point where the same road or footway crosses the line of the Oldham and Rochdale Branch of the said Lancashire and Yorkshire Railway which boundary divides the said new parish of Saint Stephen and All Martyrs Lower Moor from the new parish of Saint James Oldham aforesaid."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester.
