the Act of the thirty-fourth and thirty-fifth years of Her Majesty, chapter eighty-two, duly prepared and laid before Her Majesty in Council a representation, bearing date the thirteenth day of February in the year one thousand eight hundred and seventy-nine, in the words following; that is to

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the eighth and ninth years of your Majesty chapter seventy, of the Act of the fourteenth and fifteenth years of your Majesty chapter ninety-seven, of the Act of the nineteenth and twentieth years of your Majesty chapter fifty-five and of the Act of the thirtyfourth and thirty-fifth years of your Majesty chapter eighty-two, have prepared and now humbly lay before your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint John the Baptist situate at Newington in the outskirts of the town of Kingston-upon-Hull in the parish of Kirk Ella in the county of York and in the diocese of York.

"Whereas at certain extremities of the said parish of Kirk Ella, and of the parish of North Ferriby in the said county of York, and in the said diocese of York which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such respective

parishes. "And whereas it appears to us to be expedient that such contiguous portions of the said parish of Kirk Ella, and of the said parish of North Ferriby should be formed into a consolidated chapelry for all eccclesiastical purposes, and that the same should be assigned to the said church of Saint John the Baptist situate at Newington as

"Now, therefore, with the consent of the Right Reverend and Most Honourable William Archbishop of York with the consent of the Reverend Richard Henry Foord, Clerk in Holy Orders, now rector or incumbent of the rectory of the parish of Foxholes in the said diocese of York, the patron of the vicarage of the said parish of Kirk Ella, and with the consent of Anne Turner of Dingle Head near Liverpool in the county of Lancaster, Widow, the patron of the vicarage of the said parish of North Ferriby (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we, the said Ecclesiastical Commissioners for England, humbly represent that it would, in our opinion, be expedient that all those contiguous portions of the said parish of Kirk Ella, and of the said parish of North Ferriby which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint John the Baptist situate at Newington as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint John the Baptist Newington, Kingston-upon-Hull.'

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to your Majesty in your Royal wisdom shall seem meet.

"The Consolidated Chapelry of Saint John the Baptist Newington, Kingston-upon-Hull being :-

Kirk Ella in the county of York and in the diocese of York wherein the present incumbent of such parish now possesses the exclusive cure of souls which is bounded on the north by the parish of Cottingham in the same county and diocese on the east partly by the new parish of Saint Matthew Kingston-upon-Hull and partly by the parish of the Holy Trinity Kingston-upon-Hull both in the town and county of the town of Kingston-upon-Hull and in the diocese of York aforesaid, and upon all other sides that is to say on the south and on the west by the hereinafter described detached portion of the parish of North Ferriby in the said county of York and in the diocese of York aforesaid and also all that contiguous portion of the said parish of North Ferriby, wherein the present incumbent of such parish now possesses the exclusive cure of souls, which is detached from the main body of the same parish and is bounded on the south by the boundary, in the middle of the River Humber, which boundary divides the said county of York from the county. of Lincoln, on the east partly by the parish of the Holy Trinity, Kingston-upon-Hull and partly by the hereinbefore described portion of the parish of Kirk Ella aforesaid, on the north by the parish of Cottingham aforesaid, and on the remaining side that is to say on the west partly by the main body of the said parish of Kirk Ella and partly by the parish of Hessle in the said county of York and in the diocese of York aforesaid."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acis; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of York.
