published, and that marriages, baptisms, churchings and burials should be solemnized or performed at the said church of Saint John, situate in the chapelry of Flookburgh as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration and to make such Order with respect thereto as to your Majesty, in

your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint John, Flook-

burgh, being :-

"All that part of the parish or parochial chapelry of Cartmel in the county of Lancaster and in the diocese of Carlisle which comprises the greater portion of the territory known as the chapelry of Flookburgh and which is bounded on the west and on the south by the western and southern boundaries of the said parish or parochial chapelry of Cartmel at the ordinary highwater mark upon the sea-shore, on the greater part of the east by the new parish of Saint Mary Allithwaite in the county and diocese aforesaid, and upon all other sides that is to say on the remaining part of the east, and on the north, by an imaginary line commencing at the point where the boundary which divides the said new parish of Saint Mary Allithwaite from the parish or parochial chapelry of Cartmel aforesaid joins the boundary dividing the township of Lower Holker from the township of Lower Allithwaite at the centre of the bridge over the stream called or known as Cark Beck or the River Eea where such stream is crossed by the road or footpath leading from the house called or known as Low Bank Side into the road from Cark to Cartmel and entending thence north-eastward along the said township boundary for a distance of a quarter of a mile or thereabouts thereby following the course of the said stream to the point at its junction with the stream called or known as Mires Beck where the same township boundary is joined by the boundary dividing the said township of Lower Holker from the township of Upper Holker and extending thence north-westward along the last-mentioned township boundary for a distance of seventeen chains or thereabouts to the point where it strikes the south-eastern side of the road leading from Cartmel to Holker such point being opposite to the junction of the last-mentioned road with the footpath or occupation-road leading to the house called or known as High Bank Side and continuing thence (that is from the said point on the south-eastern side of the road leading from Cartmel to Holker as aforesaid) to a point in the middle of the last-mentioned road and extending thence south-westward along the middle of the same road for a distance of thirty chains or thereabouts (thereby following in part the boundary which divides the said township of Lower Holker from the township of Upper Holker aforesaid) to the junction of the said last-mentioned road with the road leading from Holker to the house called or known as Howbarrow and extending thence first northward and then north-westward along the hereby ordered, that the time for the discontinu-No. 24701. course of the last-described road for a distance of sixty-two chains or thereabouts (thereby following the last-mentioned township boundary) to the point on the south-western side of the hill called or known as Mount Barnard where the said township boundary diverges in a westerly direction from the said last-described road and extending thence westward along the same township boundary for a distance of a quarter of a mile or thereabouts to a point in the middle of the road leading from Backbarrow to Holker and extending thence southward along the middle of the last-described road for a distance of thirty-two chains or thereabouts (thereby skirting the foot of Bigland Scar) to the junction of the said last-described road with the road which leads from Holker across Waitham Moss, past the house called or known as Old Park, to Park Head, and thence across Cartmel Sands at low water to Ulverston and extending thence (that is from the last-described point of junction at the foot of Bigland Scar aforesaid) first westward, then north-westward and then again westward along the middle of the last-described road for a distance of one mile and forty-five chains or thereabouts, to the western boundary of the said parish or parochial chapelry of Cartmel at the ordinary high water mark upon the sea shore as aforesaid on the western side of Park Head aforesaid.'

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Carlisle.
