writing of the patron and the copies of the representation and notice before referred to are hereunto annexed.

"Fields situated at Fronlas in the parishes of Llanboidy and Eglwysfair-a-cherig in the county of Carmarthen containing twelve acres having an estimated annual value of sixteen pounds.

"And all (if any) other the glebe lands situate within the said parish of Bayvil and of right pertaining to the vicar for the time being thereof.

"All the vicarial tithes arising within the parish of Bayvil and at present received by the late incumbent of Bayvil-with-Moylgrove the estimated annual amount of which is twelve pounds that is to say all annual sum and sums of money due and payable to the vicar of the said parish of Bayvil by virtue of the award made by the apportionment of the rent-charge in lieu of tithes in the said

The farm of Mountmawr situated in the parishes of Mount and Verwick in the county of Cardigan containing an area of 132 acres 1 rood and 18 perches the estimated annual value of which is eighty-two pounds.

The farm of Mountbach situated in the same parishes with the last-named farm containing an area of thirty-three acres one rood and thirty-six perches the estimated annual value of which is twenty-five pounds.

The farm of Llechllwyd situated in the parish of Merthyr in the county of Carmarthen having an area of sixty-nine acres three roods and twentyfive perches the estimated annual value of which is ninety pounds.

The parsonage-house with field situated at Moylgrove having an area of one acre two roods and thirty-seven perches the estimated annual value of which is six pounds.
