WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant and convey to the several Incumbents of the churches or benefices named in the schedule hereunto annexed, and their successors, the several sums or payments due and payable in respect of each of the said churches or benefices respectively for procurations at the visitations to be from time to time held by the Bishop of Bath and Wells and his successors, which said procurations are now receivable by us as a part of the emoluments of the See of Bath and Wells, in virtue of the provisions contained in the Act of the twenty-third and twenty-fourth years of Her Majesty, chapter one hundred and twenty-four, and the amounts of which payments are, as far as the same can be ascertained, set forth in the said schedule, it being the intent and meaning of this grant and conveyance that such of the said procurations as have heretofore been paid or payable by the Incumbents of the several churches or benefices in respect of which they arise shall henceforth cease to be payable, and that such of the said procurations as have heretofore been paid or payable by any persons other than such Incumbents as aforesaid shall remain payable, as heretofore, by such persons or their successors, but shall be paid to and receivable by the respective Incumbents of the several churches or benefices.
