of that rectory, of the vicarage of the said new | parish of Saint George Chorley (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said new parish of Saint George Chorley, and of the said parish or parochial chapelry of Chorley which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint James situate within the limits of the new parish of Saint George, Chorley as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint James, Chorley.

"We, therefore, humbly pray that your Majestywill be graciously pleased to take the premises into your Royal consideration, and to make such order in respect thereto as to your Majesty, in

your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint James

Chorley, being :

"All that portion of the new parish of Saint George Chorley, in the county of Lancaster and in the diocese of Manchester, and also all that contiguous portion of the parish or parochial chapelry of Chorley in the same county and diocese (wherein the present incumbent of such parish or parochial chapelry now possesses the exclusive cure of souls) which said portions of such new parish and of such parish or parochial chapelry are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the new parish of Saint Peter Chorley in the said county and diocese from the parish or parochial chapelry of Chorley aforesaid at a point at the centre of Stump Bridge which carries Stump-lane over the line of the Bolton and Preston Branch of the Lancashire and Yorkshire Railway and extending thence south-eastward to and along the middle of the said branch line of railway for a distance of twenty-nine and a half chains or thereabouts (thereby crossing the boundary which divides the said parish or parochial chapelry of Chorley from the new parish of Saint George Chorley aforesaid) to the point where Lyons-lane crosses over the said line of railway, and extending thence south-westward along the middle of the last-named lane for a distance of eight chains or thereabouts to its junction with Brooke - street and extending thence eastward along the middle of the lastnamed street for a distance of six chains or thereabouts to the point where it crosses over the line of the Bolton and Preston Branch of the Lancashire and Yorkshire Railway aforesaid and extendnig thence south-eastward along the middle of the said branch line of railway for a distance of seventy chains or thereabouts (thereby crossing the Lancaster Canal) to the boundary which divides the said new parish of Saint George Chorley from the new parish of Adlington in the county and diocese aforesaid and extending thence first northward and then north-eastward along the last-mentioned boundary to its junction at the eastern end of the service reservoir of the Chorley Water Works with the boundary which divides the said new parish of Saint George Chorley from the new parish of Saint Peter Chorley aforesaid and extending thence first north-westward and boundaries of the said new parish of Dyer's Hill

then westward, northward and westward, along the last-mentioned boundary to its junction in the middle of Eaves-lane opposite to Moss Gottage with the boundary which divides the said parish. or parochial chapelry of Chorley from the new parish of Saint Peter Chorley as aforesaid and extending thence first northward and then westward along the last-mentioned boundary to the first-described point at the centre of Stump Bridge over the line of the Bolton and Preston Branch of the Lancashire and Yorkshire Railway as aforesaid, at which point the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said. representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts: and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester. The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirty-second and thirty-third years of Her Majesty chapter ninety-four duly prepared and laid before Her Majesty in Council a scheme or representation bearing date the eighth day of May, in the year one thousand eight hundred and seventy-nine, in the words following, that is to

say :—
"We the Ecclesiastical Commissioners for England acting under the provisions of the Act of the thirty-second and thirty-third years of your Majesty chapter ninety-four have prepared and now humbly lay before your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Dyer's Hill and of the new parish of Heeley both within the original limits of the parish of Sheffield in the county of York and in the diocese of York.

"Whereas by the authority of an Order of your Majesty in Council bearing date the sixth day of July in the year one thousand eight hundred and forty-six and published in the London Gazette upon the twenty-eighth day of the same month a part of the said parish of Sheffield was constituted a separate district for spiritual purposes and was named 'The District of Dyer's Hill 3 and another part of the same parish was by the like authority and at the same time constituted a separate district for spiritual purposes and was named 'The District of Heeley.'

"And whereas both the said district of Dyer's Hill and the said district of Heeley have under the provisions of the Act of the nineteenth and twentieth years of your Majesty chapter one hundred and four become new parishes of the character contemplated by that Act and by the Act of the sixth and seventh years of your Majesty chapter thirty-seven and by the said abovementioned Act of the thirty-second and thirtythird years of your Majesty chapter ninety-four.

"And whereas it has been represented to us and it appears to us to be expedient that the
