THE Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do hereby define the following part of the Port of Liverpool, in the county of Lancaster, as a foreign animals wharf:

All that space between the Canada Dock and the Huskisson Branch Dock, No. 2, in the borough of Liverpool, bounded by a line commencing at twenty-five feet or thereabouts from the westernmost angle of the north wall of the Huskisson Branch Dock, No. 2, thence running northwardly for a distance of one hundred and forty feet or thereabouts, thence eastwardly one hundred and twenty-eight feet or thereabouts along the north side of a passage ten feet in width leading to a certain slaughter-house, yard and premises, thence northwardly fifty - four feet to the north - west angle of the said slaughter-house, yard and premises, thence in an eastwardly direction two hundred and six-

teen feet or thereabouts along the north side of the said slaughter-house, yard and premises, thence northwardly one hundred and thirty-eight feet or thereabouts along the western side of certain cattle-pens and premises, thence eastwardly one hundred and twenty-four feet or thereabouts along the northern end of the said cattle-pens and premises, thence in a southwardly direction two hundred and four feet or thereabouts to the southeast angle of the aforesaid cattle-pens and premises, thence westwardly four hundred and furty-three feet or thereabouts along the southern side of the said cattle-pens, slaughter-house, yard, premises, and passage ten feet in width, thence south-wardly one hundred and thirty feet or thereabouts, thence westwardly twenty-five feet or thereabouts, terminating at the point of commencement aforesaid near the westernmost angle of the north wall of the Huskisson Branch Dock, No. 2, all which space is coloured pink on the plan of part of the borough of Liverpool deposited for the purposes of this Order at the Privy Council Office, a copy of which is deposited at the office of the Town Clerk of the borough of Liverpool.

Return of Casualties which have occurred in the Auxiliary Forces of the Cape of Good Hope between the 1st March and 30th April, 1879.

- Trooper John Tippert, Northern Border Horse, wounded in leg, resulting in death, on the 6th March, Rietfontein; born at Argle, near St. Ives, Cornwall, parents reside at Argle; about 27 years of age.
- Private Hendricks Piet, Clanwilliam Light Infantry, phthisis, died from hemoptysis, 15th March.
- Trooper A. Wilson, 2nd Yeomanry Regiment, gun-shot wound (arm), 23rd March.
- Trooper William Thompson, 2nd Yeomanry Regiment, gun-shot wound (arm), 23rd March.
- Trooper Nel, 2nd Yeomanry Regiment, gun-shot wound (shoulder), 23rd March.
- Sergeant Thomas Muldoon, 2nd Yeomanry Regiment, killed, shot through the chest, 23rd March.
- Captain Surmon, C. M. R., gun-shot wound in lung, 8th April, Morosi's Mountain, No. 5 Troop.
- Sergeant Scott, C. M. R., while throwing shell into breastworks of enemy exploded, blowing hand off and injuring legs, 8th April, Morosi's Mountain, Artillery.
- Sergeant Edwards, C. M. R., three gun-shot wounds (hip, thigh, and buttock). 8th April, Morosi's Mountain, No. 5 Troop.
