(PORT OF BARROW-IN-FURNESS.)

THE Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do hereby define the following part of the Port of Barrow-in-Furness, in the county of Lancaster, as a foreign animals wharf:—

All that space in the borough of Barrow-in-Furness situate on the south side of the Lock and Basin of the Ramsden Dock, commencing at a point at the water edge of the fifth jetty about six hundred and sixty feet from the west wing wall of the said Basin, thence in a southerly direction for about one hundred and twenty feet bounded by a wooden fence, thence for two hundred feet or thereabouts in an easterly direction bounded by a close wooden fence, thence for about one hundred feet in a southerly direction bounded by a close wooden fence, thence in an easterly direction for about two hundred and fifty feet bounded by a close fence and the outer wall of the cattle lairs, thence for one hundred and ten feet in a southerly direction bounded by the wall of the slaughter-house, thence in an easterly direction for thirty feet bounded by the wall of the slaughter-house, thence
