(No. 161.)—UNITED STATES—RHODE ISLAND, NEWPORT HARBOUR.

(1.) *Alteration in Lime Rock Light.*

THE United States Government has given notice, that on 15th October, 1879, the following alteration will be made in the colour of the light exhibited on Lime Rock, southern entrance to Newport Harbour :—

The light will be a fixed red light, instead of a fixed white as at present.

(2.) *Santo Domingo, Alteration in Light.*

(1.) *Alterations in Ispe Udde Light.*

WITH reference to Notice to Mariners, No. 171 (2), of 30th November, 1878, on the intended alterations in the light exhibited at Ispe Point, west side of Oland Island :—
