REGULATIONS

TO BE OBSERVED AT THE QUEEN'S DRAWING ROOM AT BUCKINGHAM PALACE.

By Her Majesty's Command,

The Ladies who propose to attend Her Majesty's Drawing Room, at Buckingham Palace, are requested to bring with them two large cards with their names clearly written thereon, one to be left with the Queen's Page in Attendance, and the other to be delivered to the Lord Chamberlain, who will announce the name to The Queen.

PRESENTATIONS.

Any Lady who proposes to be presented to The Queen must leave at the Lord Chamberlain's Office, St. James's Palace, before twelve o'clock, two clear days before the Drawing Room, a card with her name written thereon, and with the name of the Lady by whom she is to be presented. In order to carry out the existing regulations, that no presentation can be made at a Drawing Room excepting by a Lady actually attending that Court, it is also necessary than an intimation from the Lady who is to make the presentation, of her inten-tion to be present, should accompany the pre-sentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command, that no presentations shall be made at the Drawing Room, except in accordance with the above regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to The Queen,

It is not expected that Gentlemen will present themselves at Drawing Rooms, except in attendance on the Ladies of their families.

Any Gentleman who under these circumstances sliquid desire to be presented to The Queen, will observe the same regulations as are in force for Her Majesty's Levees.
