"And whereas the said plan is to be taken as an integral part of this scheme with respect to the whole of its contents and particularly with respect to the transfer of the patronage of the two cures of the Holy Trinity Bickerton and of Saint Chad Tushingham which in the same plan is mentioned and with respect to the augmentations of the same two cures which are mentioned in the same plan and in the fifth and sixth schedules thereto which said transfer of the patronage of the said cure of the Holy Trinity Bickerton and of the said cure of Saint Chad Tushingham has (as by the said plan appears) the consents required by the hereinbefore-mentioned Acts and is hereby recommended and proposed by us to your Majesty in Council because it appears to us that it will tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of patronage or advowson to be transferred arises or exists that is to say in the new parish of the Holy Trinity Bickerton and in the new parish of Saint Chad Tushingham respectively and which said augmentations of the said two benefices of the Holy Trinity Bickerton and of Saint Chad Tushingham have (as by the said plan appears) the consents required by the seventy-fourth section of the firstly hereinbefore mentioned Act and are hereby recommended and proposed by us to your Majesty in Council in conformity with and in pursuance of the same Act and section the said benefice of Whitewell on the one hand and the said two benefices of the Holy Trinity Bickerton and of Saint Chad Tushingham on the other being (by virtue of this scheme and of any Order of your Majesty in Council ratifying the same) benefices belonging to the same patron.

"And whereas the two maps which in the said plan are referred to as being annexed to the same plan have as well as this scheme been sealed by us with our common seal in token that the said maps as well as the said plan are to be taken as a part of this scheme and the same maps are annexed to this scheme accordingly.

"Now therefore we the said Ecclesiastical Commissioners for England humbly recommend and propose that the said plan shall as to all the contents thereof be carried into effect as in the same plan is mentioned.

"And we further recommend and propose that nothing in this scheme or in the said plan (now being part of this scheme as aforesaid) shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said for England humbly represent that it would in

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of Her Majesty, chapter ninety-seven; of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; and of the Act of the thirty-fourth and thirty-fifth years of Her Majesty, chapter eighty-two; duly prepared and laid before Her Majesty in Council a representation, bearing date the fifteenth day of April, in the year one thousand eight hundred and eighty in the words following; that is to

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty chapter seventy of the Act of the fourteenth and fifteenth years. of your Majesty chapter ninety-seven of the Act of the nineteenth and twentieth years of your Majesty chapter fifty-five and of the Act of the thirty-fourth and thirty-fifth years of your Majesty chapter eighty-two have prepared and now humbly lay before your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Andrew situate in Monton-lane in the parish of Eccles in the county of Lancaster and in the diocese of Manchester.

"Whereas at certain extremities of the said parish of Eccles and of the district chapelry of Christ Church, Patricroft, within the original limits of the parish of Eccles aforesaid which said extremities lie contiguous one to another and are described in the schedule hereunder written there is collected together a population which is situate at a distance from the several churches of such parish and district chapelry respectively.

And whereas it appears to us to be expedient that such contiguous portions of the said parish of Eccles and of the said district chapelry of Christ Church, Patricroft, should be formed intoa consolidated chapelry for all ecclesiastical purposes and that the same should be assigned to the said church of Saint Andrew situate in Montonlane as afore aid.

"Now, therefore, with the consent of the Right Reverend James Bishop of the said diocese of Manchester as such Bishop and also as the patron, in right of his See of the perpetual curacy of the said district chapelry of Christ Church, Patricroft, and with the consent of the Right Honourable-Hugh MacCalmont Earl Cairns Lord High Chancellor of Great Britain acting on behalf of your Majesty as the patron in right of the Crown of the vicarage of the said parish of Eccles (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we the said Ecclesiastical Commissioners
