thence south-eastward along the middle of the last-named road for a distance of two and a half chains or thereabouts to its junction with Summerstreet and extending thence eastward along the middle of the last-named street for a distance of two chains or thereabouts to its eastern end at its junction with Back Crescent-road and extending thence still eastward and in a direct line for a distance of six chains or thereabouts (thereby crossing the line of the Bolton and Manchester Branch of the Lancashire and Yorkshire Railway) to a point on the eastern side of the last-named branch line of railway at the middle of the western end of Albion-street at its junction with Back Earl-street and extending thence north-eastward along the middle of the said Albion-street for a distance of six and a half chains or thereabouts to its junction with Manchester-road and extending thence north-westward along the middle of the last-named road for a distance of thirteen chains or thereabouts to a point near where the said road crosses the stream called or known as Jenny Beck upon the boundary which divides the said new parish of Suint Michael Great Lever from the district parish of Trinity Bolton-le-Moors aforesaid and extending thence generally north-eastward along the last-described boundary for a distance of thirteen chains or thereabouts to the point on the northern bank of the said Jenny Beck and to the east of the buildings called or known as the Burnden Chemical Works where such boundary joins the boundary which divides the said district parish of Trinity Bolton-le-Moors from the new parish of Lever Bridge in the county and diocese aforesaid and ext-nding thence first north-eastward and then generally north-westward along the lastdescribed boundary for a distance of seventeen chains or thereabouts thereby crossing the Bury and Rochdale Branch Line of the Lancashire and Yorkshire Railway aforesaid to a point on the southern side of the buildings called or known as the Burnden Sewage Works in the middle of the roadway leading from the said sewage works into the road called or known as Rose Hill and extending thence that is from the last-mentioned boundary north-westward along the middle of the lastdescribed roadway for a distance of six and a quarter chains or thereabouts to its junction with the road called or known as Rose Hill as aforesaid and extending thence south-westward along the middle of the last-named road for a distance of nine and a half chains or thereabouts to its junction with Manchester-road aforesaid and with Lever-street aforesaid and continuing thence south-westward along the middle of the last-named street for a distance of twenty chains or thereabouts to the first described point opposite to the boundary - stone above - mentioned upon the houndary which divides the said district parish of Trinity Bolton-le-Moors from the new parish of Saint Mark Bolton-le-Moors atoresaid at which point the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester.

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyard be postponed as follows; viz.:—

In Christchurch Chu chvard, in the county of Monmouth, to the thirty-first day of De ember, one thousand eight hundred and eighty.

The QUEEN's Most Excellent Majesty in Council WHERE AS the Right Honourable Sir William VV Vernon Harcourt, one of Her Majesty's Principal Secretaries of State, after giving to the Incumbents and the Churchwardens of the parishes hereinafter mentioned ten days' previous notice of his intention to make such representation, has, under the provisions of an Act passed in the session of Parliament held in the sixteenth and seventeenth years of Her Majesty's reign, intituled "An Act to amend the laws concerning the burial "of the dead in England beyond the limits of the "Metropolis, and to amend the Act concerning " the burial of the dead in the Metropolis," made a representation stating that, for the protection of the public health, no new burial ground should be opened in the undermentioned parishes without the previous consent of one of Her Majesty's Principal Secretaries of State, and that burials should be discontinued therein as follows, viz.:-

HILPERTON—Forthwith wholly in the Baptist Burial-ground at Hilperton, in the county of Wilts.

HEADINGTON — Forthwith in Headington Churchyard, in the county of Oxford, in the part south of the church; and in the part north of the church after the first day of January, one thousand eight hundred and eighty-one, except in existing vaults and walled graves, every coffin buried in which shall be separately enclosed by stonework or brickwork properly cemented, and except in earthen graves which
