THE Queen has been pleased to grant unto the Right Honourable Edward Montagu Stuart Granville Stuart-Wortley-Mackenzie, Earl of Wharncliffe and to Francis Dudley Stuart-Wortley (commonly called the Honourable Francis Dudley Stuart-Wortley), of Scarborough, in the West Riding of the county of York, the only surviving sons of John Stuart-Wortley-Mackenzie, second Baron Wharncliffe, deceased, Her Royal licence and authority that he, the said Edward Montagu Stuart Granville Stuart-Wortley-Mackenzie, Earl of Wharncliffe, may take the surname of Montagu, in addition to and before those of Stuart-Wortley-Mackenzie, and bear the arms of Montagu quarterly with those of Stuart Wortley and Mackenzie. and that he, the said Francis Dudley Stuart Wortley and his issue, may take and use the surname of Montagu before those of Stuart-Wortley, and that he and they may bear the arms of Montagu quarterly with those of Stuart and Wortley; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.
