And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Winchester.

**T**HE Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, (in this Order referred to as the Act of 1878,) and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The area described in the Schedule to this Order, except the lines of railway within that area as far as those lines are used or required for the transit of animals through that area, without being untrucked within it, (with which transit nothing in this Order shall be deemed to interfere,) is hereby declared to be an area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the twenty-first day of January, one thousand eight hundred and eighty-one; and words in this Order have the same meaning as in the Act of 1878.

#### SCHEDULE.

An area comprising the Petty Sessional Divisions of Alton, Basingstoke, Fareham, Havant, Odiham, Petersfield, and Southampton, in the county of Southampton, and the boroughs of Basingstoke, Portsmouth, and Southampton, except as follows:—The Royal Clarence Victualling Yard and the other lands and buildings in the port of Portsmouth approved by the Privy Council for the landing or lairage of foreign animals; the foreign animals wharf, and the foreign animals quarantine stations, and the other lands and buildings in the port of Southampton, approved or defined by the Privy Council for the landing or lairage or for the quarantine of foreign animals; and such landing-places in the port of Southampton as are at the date of this Order used for the landing of animals from Ireland.

THE Queen has been graciously pleased to confer the "Albert Medal of the Second Class" on—

SURGEON HENRY GRIER, Army Medical Department.

The following is the account of the services in respect of which the decoration has been conferred:—

On the 26th of August, 1880, Lieutenant Graham, 10th Regiment, was dying of diphtheria, when SURGEON GRIER performed upon him the operation of tracheotomy: and, observing that no attempt at inspiration followed, applied his lips without a moment's hesitation to the wound, and, by suction, at the imminent risk of his own life, restored to the patient the power of breathing. Lieutenant Graham's life was thus saved for the time, although, unfortunately, on the following day the disease extended to his lungs, and he died.
