THE Board of Trade have received through the Secretary of State for Foreign Affairs the following telegram from Her Majesty's Agent and Consul-General in Egypt, respecting the quarantine arrangements which have been made in that country in consequence of the outbreak of plague n Mesopotamia:

" THE following precautions have been taken in " Egypt, in consequence of outbreak of plague in

" Mesopotamia. Arrivals from Persian Gulf sub-" ject to seven days' quarantine, or fifteen days in case of sickness on board; ships which have com-"municated with ships from Persian Gulf subject to like provisions. Vessels going to Mediter"ranean ports with clean bill of health, may, if no " suspicious incident has occurred during voyage, " and their sanitary condition be satisfactory, tra-" verse the Canal in quarantine after favourable " medical inspection; in the contrary case, they "will undergo fifteen days' quarantine at Tor. "Vessels from Syria to be admitted only after " medical inspection and favourable report. Re-" peated to Malta, Gibraltar, and Aden."
