and in the diocese of Worcester which is bounded on the north by the county of Stafford, on the east partly by the said parish of Aston-juxta-Birmingham and partly by the new parish of Saint Mary Aston Brook in the county of W a wick and diocese of Worcester aforesaid on the south partly by the new parish of Saint Stephen Birmingham, and partly by the new parish of Saint Matthias Birmingham, both in the county of Warwick and diocese of Worcester aforesaid and on the remaining side, that is to say on the west by an imaginary line commencing on the boundary which divides the last-named new parish from the said new parish of Saint Silas Lozells at the point where Berners-street crosses Hockley Brook, and extending thence northward along the middle of such street for a distance of twenty-eight chains and a half or thereabouts to its junction with Lozells-road and extending thence eastward along the middle of the said road for a distance of one chain and a quarter or thereabouts to the junction of such road with Hartington-road and extending thence northward along the middle of the lastnamed road for a distance of six and a quarter chains or thereabouts to its junction with Carlyleroad and extending thence westward along the middle of the last-named road for a distance of two chains or thereabouts to its junction with a certain new road or street called or known as Roland-road and extending thence northward along the middle of such new road or street for a distance of one and three-quarter chains or thereabouts to the boundary which divides the said county of Warwick from the county of Stafford aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Worcester., C. say:—
"We the Ecclesiastical Commissioners for England in pursuance of the Act of the fiftyninth year of His Majesty King George the Third chapter one hundred and thirty-four of the Act of the second and third years of your Majesty, chapter forty-nine, and of the Act of the nineteenth and twentieth years of your Mujesty

representation as to the assignment of a district chapelry to the consecrated church of Saint Michael and All Angels situate within the limits of the parish of All Saints Wigan in the county of Lancaster and in the diocese of Liverpool.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Michael and All Angels situate within the limits of the parish of All Saints,

Wigan as aforesaid.

"Now therefore with the consent of the Right Reverend John Charles Bishop of the said diocese of Liverpool (testified by his having signed and sealed this representation) we the said Ecclesiastical Commissioners humbly represent that it would in our opinion be expedient that all that part of the said parish of All Saints Wigan which is described in the schedule hereunder written, all which part, together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed should be assigned as a district chapelry to the said church of Saint Michael and All Angels situate within the limits of the parish of All Saints Wigan as aforesaid, and that the same should be named 'The District Chapelry of Saint Michael and All Angels Wigan.

"And with the like consent of the said John Charles Bishop of the said diocese of Liverpool (testified as aforesaid) we the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms churchings and burials should be solemnized or performed at the said church of Saint Michael and All Angels situate within the limits of the parish of All Saints Wigan as aforesaid and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always that so long as the Honourable and Reverend George Thomas Orlando Bridgeman the present rector or incumbent of the rectory of the said parish of All Saints Wigan shall continue to be such rector or incumbent all the fees which may be received in respect of such publication solemnization or performance at the said church of Saint Michael and All Angels situate within the limits of the parish of All Saints Wigan as aforesaid shall be paid over by the minister thereof to the said George Thomas Orlando Bridgeman and provided also that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the perform-ance of the said office of baptism or for the registration thereof.

"We therefore humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration and to make such Order with respect thereto as to your Majesty in your Royal wisdom shall seem meet.'
