1. The limits of the area which is described in the Order of Council dated the fourth day of June, one thousand eight hundred and eighty-one, and is thereby declared to be an area infected with foot-and-mouth disease, namely,—the urban sanitary district of Trowbridge, the parishes of North Pradley, West Ashton, Keevil, Hinton,

Semington, Whaddon, and Hilperton, and the tything of Staverton, in the county of Wilts,—are hereby extended so as to include the area described in the Schedule to this Order, and the area described in the Schedule to this Order is hereby declared to be an area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the fifteenth day of June, one thousand eight hundred and eighty-one.
