THE Board of Trade have received from the Secretary of State for Foreign Affairs a copy of the following Telegram from Her Majesty's Consul at Alexandria respecting quarantine regulations in Egypt:—

June 21, 1881.—Egyptian Board of Health decided to-day to admit passengers and goods from Syria to free pratique after medical inspection. Passengers from Turkish Red Sea Ports to undergo one day quarantine at Suez with disinfection of luggage. Susceptible goods, accompanied by certificate of origin from non-infected districts, admitted to pratique; others repelled. Rags and other highly susceptible goods from Syria or Red Sea Turkish Ports repelled. Quarantine regulations respecting Persian Gulf unchanged.
